A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF MANATEE COUNTY, FLORIDA, RESCINDING RESOLUTION R-10-246, AND FINDING THAT "PROJECT GOLD" IS A QUALIFIED TARGET INDUSTRY BUSINESS PURSUANT TO §288.106, FLORIDA STATUTES, AND PROVIDING LOCAL FINANCIAL SUPPORT FOR PARTICIPATION IN THE QUALIFIED TARGET INDUSTRY (QTI) TAX REFUND PROGRAM, FOR FISCAL YEAR 2012-2013 THROUGH 2017-2018 AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Board adopted Resolution R-10-246 on December 14, 2010 which reflected the wrong reimbursement dates for Project GOLD; and

WHEREAS, Project GOLD is a manufacturing company identified as a Florida Target Industry Business designated under Section 288.108, Florida Statutes; and

WHEREAS, the location of Project GOLD in Manatee County will result in the creation of manufacturing jobs; and

WHEREAS, Project GOLD will locate manufacturing operations to Manatee County that will create 30 new jobs; and

WHEREAS, Project GOLD is an employer that pays above 115% of the Manatee County average annual wage; and

WHEREAS, expansion of the tax base and growth of higher paying jobs is vital to maintaining economic diversity and improving quality of life in Manatee County; and

WHEREAS, the Manatee County Board of County Commissioners is willing to participate financially in inducements required to convince Project GOLD to expand their business in Manatee County; and

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Manatee County, Florida, that:

1. The Board of County Commissioners of Manatee County hereby rescinds Resolution R-10-246.
2. In accordance with §288.106(4)10, the Board of County Commissioners of Manatee County hereby recommends Project GOLD be approved as a Qualified Target Industry Business.
3. If the State enters into a tax refund agreement pursuant to the representations contained in the application of Project GOLD, the Board of County Commissioners of Manatee County, Florida, agrees to participate financially with the State in offering inducements to Project GOLD to locate its facility


within Manatee County for the creation of 30 jobs in amounts not to exceed a total of \$18,000 for the following programs:


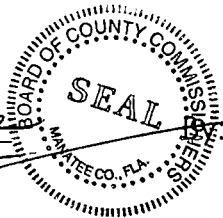

If the State enters into a tax refund agreement pursuant to the representations contained in the application of Project GOLD, the Board of County Commissioners of Manatee County, Florida, agrees to participate financially with the State in offering inducements to Project GOLD to locate its facility within Manatee County for the creation of 30 jobs in amounts not to exceed a total of \$18,000 for the following programs:


