

RESOLUTION NO. R-11-189

**A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF MANATEE COUNTY, FLORIDA, ESTABLISHING THE RATES AND FEES FOR LICENSING SEXUALLY ORIENTED BUSINESSES IN MANATEE COUNTY; MAKING RELATED FINDINGS; AND PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, §125.01(1)(f), Florida Statutes, authorizes the Board of County Commissioners of Manatee County, Florida, as the legislative and governing body of Manatee County, to establish the amount of fees and rates associated with the licensing of sexually oriented business operations in Manatee County; and

**WHEREAS**, the Manatee County Building and Development Services Department is funded in part by such fees generated to cover all or a portion of the costs of such licensing services and regulation so as to minimize the burden on the County's general revenue; and

**WHEREAS**, the County Commission has previously adopted fees which have been made a part of the Building and Development Services Department Master Fee Schedule; and


**WHEREAS**, the new or revised fees now recommended for adoption are based upon the Building and Development Services Department's review of the costs necessary to review and permit sexually oriented businesses.

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MANATEE COUNTY, FLORIDA, AS FOLLOWS:**


1. A licensing rates and fees schedule is attached hereto as Exhibit A and is approved for use in licensing under Chapter 2-2.5 of the Manatee County Code.
