

RESOLUTION R-14-030

A RESOLUTION AMENDING MANATEE COUNTY RESOLUTION R-12-108 *NUNC PRO TUNC*, AUTHORIZING USE OF “QUICK TAKING” CONDEMNATION PROCEEDINGS FOR THE PUBLIC USE AND PUBLIC PURPOSE OF CONSTRUCTION ACTIVITIES, WIDENING, DEEPENING, DREDGING, CLEARING AND SNAGGING OF THE BANKS, OR OTHERWISE IMPROVING THE WARE’S CREEK FLOODWAY AND STORM WATER IMPROVEMENT AREA AS PART OF THE WARE’S CREEK STORM WATER FLOOD CONTROL PUBLIC PROJECT IN MANATEE COUNTY, FLORIDA.

**WARE’S CREEK - CANAL DREDGING
PARCELS W-261.1, W-261A.1, W-262.1, AND W-262.6

WHEREAS, on May 8, 2012, the Board of County Commissioners of Manatee County duly adopted Resolution R-12-108 authorizing use of “quick taking” condemnation proceedings for the acquisition of certain parcels of privately owned realty necessary for the Ware’s Creek – Canal Dredging Project (“Project”) and rescinding and replacing Resolution R-12-025; and

WHEREAS, as a result of an error in the examination of title work, the legal description and sketch for Parcel W-261A.1 did not capture the entirety of the real estate needed to be acquired for the Project; and

WHEREAS, Manatee County has determined the need to revise the legal description and sketch of the area of acquisition for Parcel W-261A.1 to increase the land area needed for improvements; and

WHEREAS, Manatee County, Florida, has made an effort to acquire certain property interests along or within the planned corridor of the Project by purchase from the owners; and

WHEREAS, the Board of County Commissioners has heretofore authorized the institution of eminent domain proceedings to acquire said properties, all as described and set out in Resolution R-12-107; and

WHEREAS, the Board of County Commissioners wishes to utilize “quick taking” condemnation proceedings.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MANATEE COUNTY, FLORIDA, that the Board of County Commissioners of Manatee County, Florida, authorized on May 8, 2012, the use of “quick taking” eminent domain proceedings under Chapter 74, Florida Statutes, and all other applicable statutes, and that the Board of County Commissioners declares its intention to utilize such proceedings to acquire the necessary interests in the real property as described on Schedule No.

2, attached hereto and incorporated herein by this reference, for the purpose of construction and related improvements for the Project.

BE IT FURTHER RESOLVED that Resolution R-12-108 is hereby amended to replace Schedule No. 2 thereto (Parcel W-261A.1 – Fee Simple Title) with the legal description and sketch attached hereto as Schedule No. 2 (Amended Parcel W-261A.1 – Fee Simple Title), reflecting the revised legal description and sketch of the area of acquisition needed for improvements, and including and incorporating the property described in Schedule No. 2 hereto together with all references to Schedule No. 2 in Resolution R-12-108.

BE IT FURTHER RESOLVED that Resolution R-12-108 be otherwise unaltered and remain in full force and effect, as amended hereby.

BE IT FURTHER RESOLVED, *nunc pro tunc*, that the Board of County Commissioners of Manatee County, Florida, hereby adopts the aforementioned amendments effective as of May 8, 2012, the date of adoption of Resolution R-12-108.

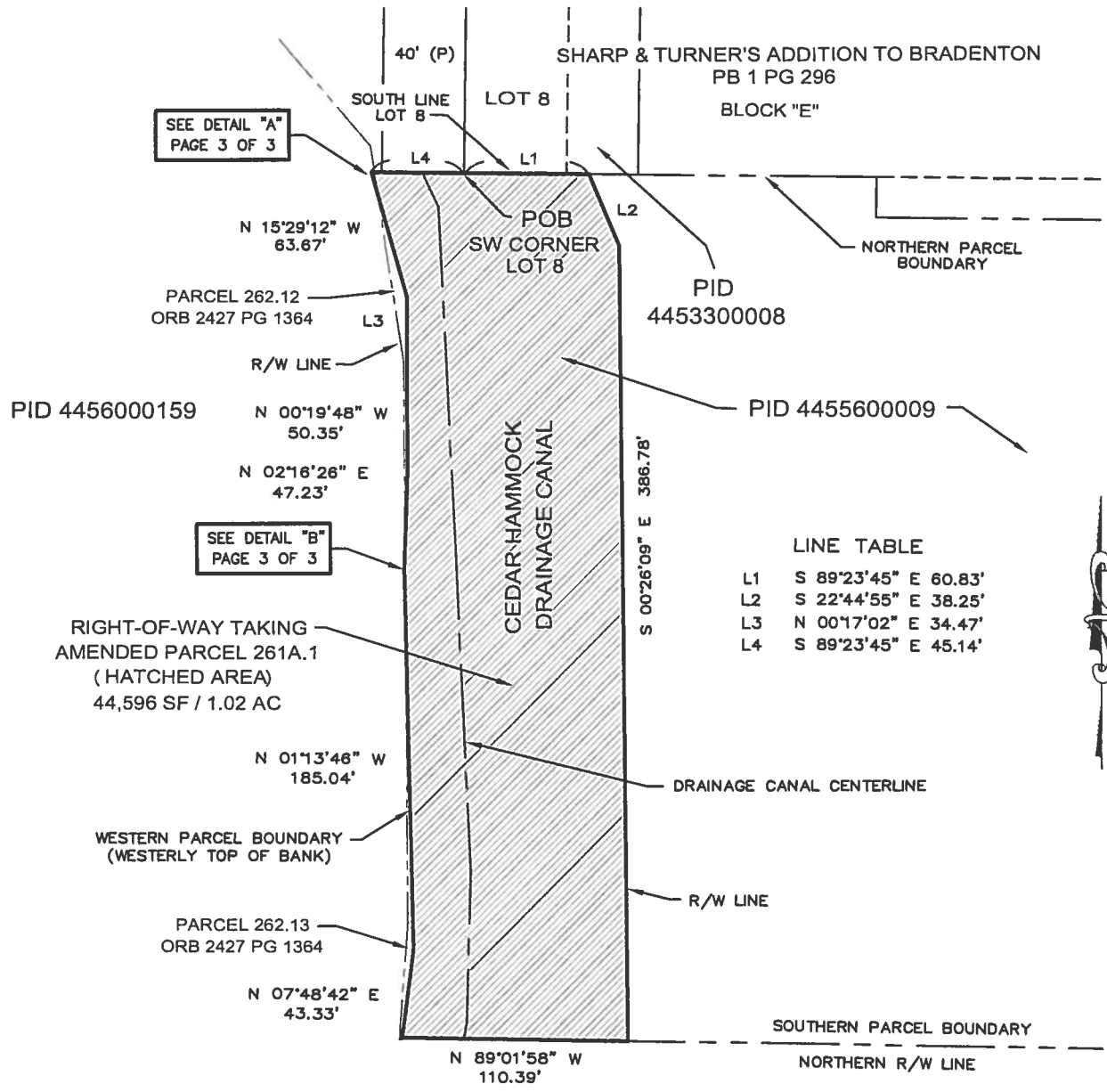

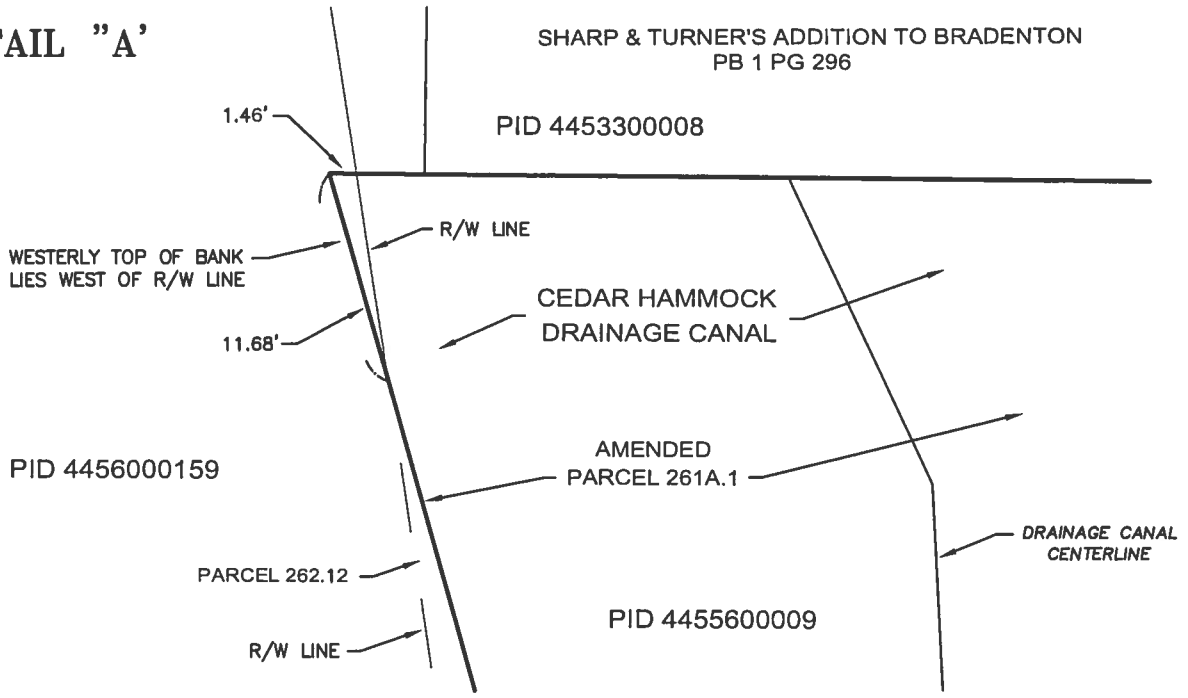

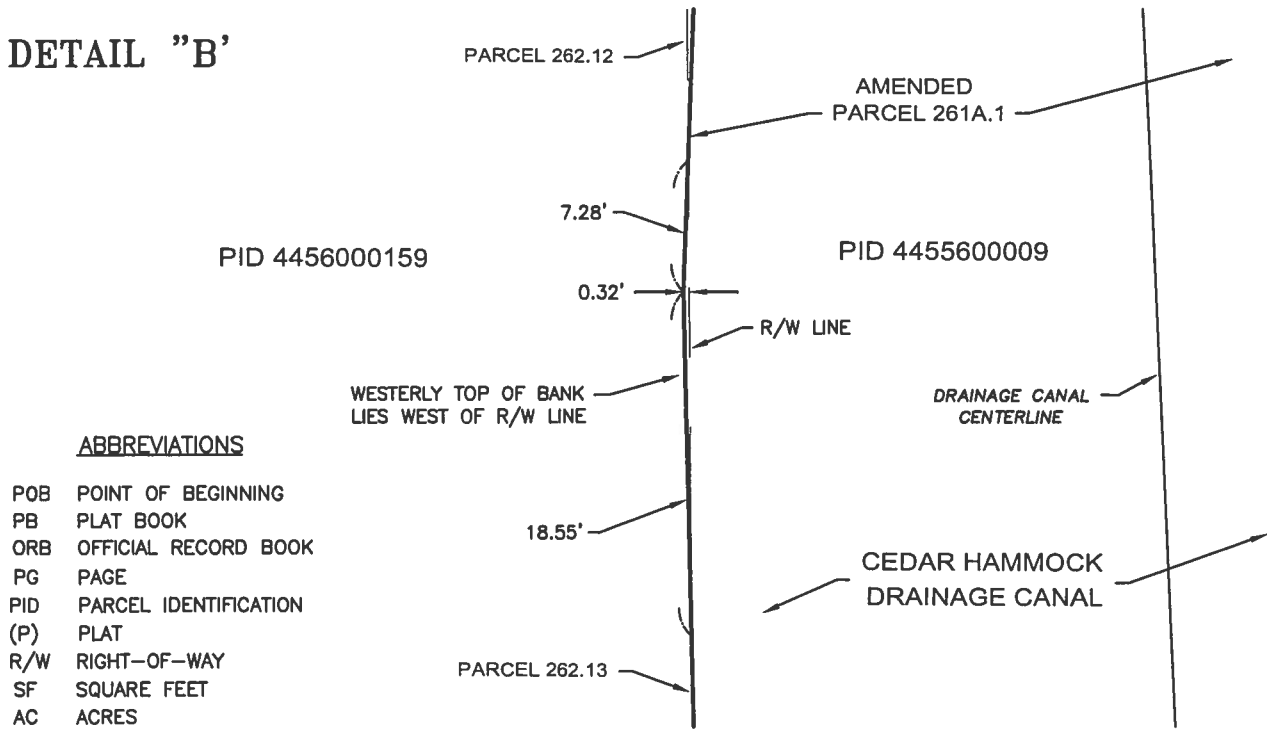
