

RESOLUTION NO. R-14-88

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF MANATEE COUNTY, FLORIDA, RELATING TO 14TH STREET WEST COMMUNITY REDEVELOPMENT AREA ADVISORY BOARD; REPEALING AND RESCINDING RESOLUTION NO. R-03-243, WHICH CREATED AND ESTABLISHED THE 14TH STREET WEST COMMUNITY REDEVELOPMENT AREA ADVISORY BOARD, AND RESOLUTION R-11-248, WHICH AMENDED THE QUALIFICATIONS OF MEMBERS OF SAID ADVISORY BOARD; ABOLISHING THE 14TH STREET WEST COMMUNITY REDEVELOPMENT AREA ADVISORY BOARD; PROVIDING DIRECTIONS REGARDING CODIFICATION; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, pursuant to Resolution No. R-02-312 adopted on November 19, 2002, the Board of County Commissioners of Manatee County, Florida, declared itself to be the community redevelopment agency of the community redevelopment area for 14th Street West; and

WHEREAS, on November 18, 2003, the Board of County Commissioners of Manatee County, Florida, adopted Resolution No. R-03-243, which created and established the 14th Street West Community Redevelopment Area Advisory Board; and

WHEREAS, on November 21, 2011, the Board of County Commissioners of Manatee County, Florida, adopted Resolution R-11-248, which amended the qualifications of members of the 14th Street West Community Redevelopment Area Advisory Board; and

WHEREAS, Chapter 163, Part III, Florida Statutes, as amended (the Florida Community Redevelopment Act of 1969), does not require an advisory board for a community redevelopment area; and

WHEREAS, the Board of County Commissioners of Manatee County, Florida, desires to abolish the 14th Street West Community Redevelopment Area Advisory Board created by Resolution No. R-03-243 and amended by Resolution R-11-248; and

WHEREAS, the Board of County Commissioners of Manatee County, Florida, has determined that it is in the best interest of the Manatee County Community Redevelopment Agency and the residents of the County to repeal and rescind Resolution No. R-03-243 and Resolution R-11-248 and to abolish the 14th Street West Community Redevelopment Area Advisory Board as provided in this resolution.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MANATEE COUNTY, FLORIDA:

Section 1. Resolution No. R-03-243, which created and established the 14th Street West Community Redevelopment Area Advisory Board, and Resolution R-11-248, which amended the qualifications of members of said Advisory Board, are hereby repealed and rescinded in their entirety.

Section 2. The 14th Street West Community Redevelopment Area Advisory Board,

created and established by Resolution No. R-03-243 and amended by Resolution R-11-248, is hereby abolished.

Section 3. This resolution shall not be codified in the Manatee County Code of Resolutions.

Section 4. This resolution shall take effect immediately upon adoption.
