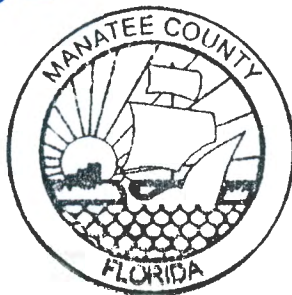
WHEREAS, the Federal Transit Administration requires that all direct and primary recipients document their compliance with Title VI requirements by submitting a Title VI Program Update once every three (3) years ; and

WHEREAS, the Board of County Commissioners must approve each Title VI Program Update prior to submission to the Federal Transit Administration (FTA).


NOW THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Manatee County, Florida, that:

1. The BOARD has the authority to submit the 2016 Title VI Program Update.
2. The Chairperson, or Vice Chairperson, is hereby authorized to sign the Title VI Program Update transmittal letter.
3. The BOARD authorizes the Transit Division Manager to submit the 2016 Title VI Program Update to FTA, and sign any and all assurances, warranties, certification and other supporting documentation which may be required in connection with the 2016 Title VI Program Update.
