

RESOLUTION NO. R-17-042

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONER OF MANATEE COUNTY, FLORIDA, AMENDING RESOLUTION R-16-174 OF THE PARKS AND NATURAL RESOURCES FEE SCHEDULE; PROVIDING FOR SEVERABILITY AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, §125.01(1)(f), Florida Statutes, authorizes the Board of County Commissioners of Manatee County, Florida, as the legislative and governing body of Manatee County, to provide parks, preserves, playgrounds, recreation areas, and other recreation and cultural facilities and programs; and

WHEREAS, parks and natural resources services are funded in part by user fees generated to cover all or a portion of the costs of such services so as to minimize the burden on the County's general revenue;

WHEREAS, Manatee County's parks and preserves are open to the public and used for the operation of planned special events organized and supervised by the Parks & Natural Resources Department; and

WHEREAS, Manatee County Code §2-24-12 provides that the Board of County Commissioners may, upon recommendation of the Parks and Natural Resources Department Director, adopt, modify or rescind fees or fee ranges for access to various facilities or services offered by the County; and

WHEREAS, the County Commission has previously adopted various fees which have been made a part of the Parks and Natural Resources Master Fee Schedule, and

WHEREAS, the changes now recommended for adoption are based upon clarification to the Field Use policy and various fees, removal of fee no longer used, addition of new fees, and increasing various fees throughout the Master Fee Schedule.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MANATEE COUNTY, FLORIDA, THAT:

1. The fee changes in Resolution R-17-042 are hereby amended, providing for the following changes to the Master Fee Schedule:
 - a. Remove \$50 Late Fee language from Field Use Policy. (p.5)
 - b. Add Free Swim Day Fee. (p.13)
 - c. Clarify Field Rental Late Fee and what teams are exempt from Processing Fee and Late Fee. (p.14)
 - d. Clarify Concession Storage Fee is non-taxable. (p.14)
 - e. Remove County Affiliated League and Commercial Ball Field Reservation Fees no longer used. (p.15)
 - f. Remove Drag Field Fee no longer used. (p.15)
 - g. Add new Team Training (staff led) Fees. (p.18)
 - h. Add new Personal Trainer (instructor) Fees for Team Training. (p.18)
 - i. Remove Water Aerobics Fee. (p.24)
 - j. Increase Swim Diaper Fee and clarify fee includes sales tax. (p.24)
 - k. Clarify, Remove, Add, Increase, and Decrease various athletic program fees (basketball, dodgeball, football, Frisbee, road run, softball, volleyball, and whiffleball). (p.25-26)
 - l. Add Professional Development Training/Workshop Fee. (p.28)
 - m. Clarify various Youth Camps Program Fees and Remove fees no longer used. (p.28)
 - n. Increase Junior Blast Camp (Jr. Counselor) Fee. (p.28)
2. Fee changes shall take effect as of April 4, 2017.


BE IT FURTHER RESOLVED that the provisions of this resolution are severable such that the invalidity of any one provision shall not operate to invalidate any other provision.
