

RESOLUTION R-17-044

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF MANATEE COUNTY, FLORIDA, RELATING TO THE BOARD OF COMMISSIONERS OF MYAKKA CITY FIRE CONTROL DISTRICT; APPOINTING COMMISSIONERS TO DISTRICT SEAT 2 AND DISTRICT SEAT 4; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, on May 8, 2007, the Board of County Commissioners of Manatee County, Florida, adopted and enacted Ordinance No. 07-56, codified at Chapter 2-27 of the Manatee County Code, providing for the Myakka City Fire Control District; and

WHEREAS, Section 2-27-3 of the Manatee County Code provides that the business and affairs of the Myakka City Fire Control District shall be conducted and administered by a board of five (5) commissioners; and

WHEREAS, Section 2-27-4 of the Manatee County Code provides that the Board of County Commissioners shall by resolution appoint the commissioners to the Myakka City Fire Control District to staggered terms of four (4) years each; and

WHEREAS, on June 19, 2007, the Board of County Commissioners appointed the five (5) commissioners to the Myakka City Fire Control District; and

WHEREAS, pursuant to Section 2-27-4 of the Manatee County Code, each commissioner of the Myakka City Fire Control District appointed to an even-numbered district was appointed for an initial term of two (2) years commencing on June 1, 2007, and four (4)-year terms thereafter; and

WHEREAS, on July 30, 2013, the Board of County Commissioners adopted Resolution R-13-120 appointing commissioners to District Seat 2 and District Seat 4 of the Myakka City Fire Control District for a term of four (4) years; and

WHEREAS, on July 28, 2015, the Board of County Commissioners adopted Resolution R-15-129 appointing a commissioner to fill an unexpired term for District Seat 2 of the Myakka City Fire Control District expiring on May 31, 2017; and

WHEREAS, the Board of County Commissioners desires to reappoint commissioners to District Seat 2 and District Seat 4 of the Myakka City Fire Control District for a term of four (4) years each, expiring on May 31, 2021.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Manatee County, Florida, that:

1. The Board of County Commissioners hereby reappoints the following commissioners of the Myakka City Fire Control District for a term of four (4) years each commencing on June 1, 2017:

- a. Jason McKendree to District Seat 2; and
- b. Robert E. Hendrickson to District Seat 4.

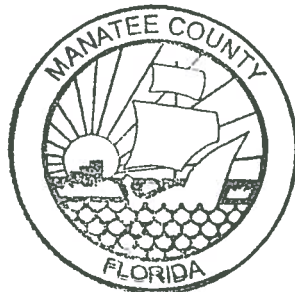

BE IT FURTHER RESOLVED that should any section, subsection, sentence, clause, or provision of this Resolution be determined to be unconstitutional, invalid, inoperative, void, or otherwise unenforceable by a court of competent jurisdiction, such finding shall not affect the remaining portions of this Resolution so long as the remaining portions can be given legal effect absent the invalid portions.

BE IT FURTHER RESOLVED that this Resolution shall take effect on June 1, 2017, at 12:01 a.m.
