- The Public Works Director or in his absence, the Public Work Deputy Director for Field Operations, is hereby authorized to electronically sign and/or submit these applications and accept grant awards, and/or expand grant funds for approved purposes as identified in the Federal Fiscal Year 2017 Program of Projects, pursuant to grant award, unless specifically rescinded.
- The BOARD authorizes the Transit Division Manager to sign any and all assurances, 5. reimbursement invoices, warranties, certification and other documents which may be required in connection with these grants applications or subsequent grant agreements.
