PROJECT CRYSTAL**

A RESOLUTION BY THE BOARD OF COUNTY COMMISSIONERS OF MANATEE COUNTY, FLORIDA, FINDING THAT PROJECT CRYSTAL BE APPROVED AS A QUALIFIED TARGET INDUSTRY BUSINESS PURSUANT TO s.288.106, FLORIDA STATUTES; AND PROVIDING FOR LOCAL FINANCIAL SUPPORT IN THE FORM OF CASH FOR THE QUALIFIED TARGET INDUSTRY (QTI) TAX REFUND FOR FISCAL YEARS 2018-2019 THROUGH 2025-2026 AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, Project CRYSTAL is an expanding aviation/aerospace manufacturing company identified as a Florida Target Industry Business designated under Section 288.106, Florida Statutes; and

WHEREAS, the location of Project CRYSTAL in Manatee County will create 52 new jobs over the next five years; and

WHEREAS, Project CRYSTAL will commit to pay an average wage of \$57,738 which is at least 150% of the Manatee County average annual wage; and

WHEREAS, Manatee County hereby acknowledges that local financial support of 20% of the total tax refund is required under the provisions of s.288.106, Florida Statutes, governing the State's Qualified Target Industry Tax Refund Program and will contribute local financial support for the Qualified Target Industry Tax Refund Program.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Manatee County, Florida, that:

1. Resolution R-17-092 is hereby adopted.
2. In accordance with s.288.106(4)10, Florida Statutes, the Board of County Commissioners of Manatee County hereby recommends Project CRYSTAL be approved as a Qualified Target Industry Business.
3. If the State enters into a tax refund agreement pursuant to the representations contained in the application for Project CRYSTAL, the Board of County Commissioners of Manatee County, Florida, agrees to participate financially with the State in offering inducements to Project CRYSTAL to locate its facility within Manatee County for the creation of 52 quality jobs in amounts not to exceed a total of \$62,400 for the Qualified

Target Industry Tax Refund. This amount will be made available in accordance with guidelines set forth by the Department of Economic Opportunity pursuant to s.288.106, Florida Statutes.
