PROJECT OMEGA II**

**A RESOLUTION BY THE BOARD OF COUNTY COMMISSIONERS OF MANATEE COUNTY, FLORIDA, FINDING THAT PROJECT OMEGA BE APPROVED AS A QUALIFIED TARGET INDUSTRY BUSINESS PURSUANT TO s.288.106, FLORIDA STATUTES; AND PROVIDING FOR LOCAL FINANCIAL SUPPORT IN THE FORM OF CASH FOR THE QUALIFIED TARGET INDUSTRY (QTI) TAX REFUND FOR FISCAL YEARS 2018-2019 THROUGH 2023-2024 AND PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, Project OMEGA II is a locating global logistics warehouse company identified as a Florida Target Industry Business designated under Section 288.106, Florida Statutes; and

**WHEREAS**, the location of Project OMEGA II in Manatee County will create 40 new jobs over the next five years; and

**WHEREAS**, Project OMEGA II will commit to pay an average wage of \$44,266 which is at least 115% of the Manatee County average annual wage; and

**WHEREAS**, Manatee County hereby acknowledges that local financial support of 20% of the total tax refund is required under the provisions of s.288.106, Florida Statutes, governing the State's Qualified Target Industry Tax Refund Program and will contribute local financial support for the Qualified Target Industry Tax Refund Program.

**NOW, THEREFORE, BE IT RESOLVED** by the Board of County Commissioners of Manatee County, Florida, that:

1. Resolution R-17-099 is hereby adopted.
2. In accordance with s.288.106(4)10, Florida Statutes, the Board of County Commissioners of Manatee County hereby recommends Project OMEGA II be approved as a Qualified Target Industry Business.
3. If the State enters into a tax refund agreement pursuant to the representations contained in the application for Project OMEGA II, the Board of County Commissioners of Manatee County, Florida, agrees to participate financially with the State in offering inducements to Project OMEGA II to locate its facility within Manatee County for the creation of 40 quality jobs in amounts not to exceed a total of \$24,000 for the

Qualified Target Industry Tax Refund. This amount will be made available in accordance with guidelines set forth by the Department of Economic Opportunity pursuant to s.288.106, Florida Statutes.
