

**RESOLUTION NO. R-17-132**

**A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONER OF MANATEE COUNTY, FLORIDA, AMENDING RESOLUTION R-17-042 OF THE PARKS AND NATURAL RESOURCES FEE SCHEDULE; PROVIDING FOR SEVERABILITY AND PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, §125.01(1)(f), Florida Statutes, authorizes the Board of County Commissioners of Manatee County, Florida, as the legislative and governing body of Manatee County, to provide parks, preserves, playgrounds, recreation areas, and other recreation and cultural facilities and programs; and

**WHEREAS**, parks and natural resources services are funded in part by user fees generated to cover all or a portion of the costs of such services so as to minimize the burden on the County's general revenue;

**WHEREAS**, Manatee County's parks and preserves are open to the public and used for the operation of planned special events organized and supervised by the Parks & Natural Resources Department; and

**WHEREAS**, Manatee County Code §2-24-12 provides that the Board of County Commissioners may, upon recommendation of the Parks and Natural Resources Department Director, adopt, modify or rescind fees or fee ranges for access to various facilities or services offered by the County; and

**WHEREAS**, the County Commission has previously adopted various fees which have been made a part of the Parks and Natural Resources Master Fee Schedule, and

**WHEREAS**, the changes now recommended for adoption are based upon clarification to the Field Use policy and various fees, removal of fee no longer used, addition of new fees, and increasing various fees throughout the Master Fee Schedule.

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MANATEE COUNTY, FLORIDA, THAT:**

1. The fee changes in Resolution R-17-132 are hereby amended, providing for the following changes to the Master Fee Schedule:
  - a. Add John H. Marble Pool – Class Drop-in fee. (p.12)
  - b. Clarify hard court and clay court subsequent total hours use with Daily Fees. (p.17)
  - c. Increase 30-minute and 1-hour Personal Training Session fees, and grant previous fee to current participating members until Dec 31, 2018. (p.17)
  - d. Clarify instructor led Team Training as opposed to staff led training. (p.17)
  - e. Remove Your Choice Health Plan fee, due to scrivener's error to remove with adoption of R-16-174 on December 13, 2016. (p.20)
  - f. Remove Non-County Run Tournament Fee. (p.26)
  - g. Add the following Racquet Center Program fees for members and non-members: (p.26)
    - o USTA Super Senior National Tournament Host and Vendors
    - o Community Tennis Outreach Promotional Events and Vendors
    - o Pickleball 101 (Hard Courts or Indoor Gymnasium)
    - o Team Drill (Clay Courts and Hard Courts)
    - o Doubles Strategy (Clay Courts and Hard Courts)
    - o Doubles Partner Workout (Clay Courts and Hard Courts)
    - o Tennis 101/Fitness (Clay Courts and Hard Courts)
    - o Private Lessons (Pickleball/Tennis)
  - h. Remove special events and recreation classes from Youth Camps programs. (p.27)

- i. Create a Program/Education/Volunteer page to include clarification of current programs and add new programs with fees. Fees will be based upon number of people estimated to attend and the overall material cost: (p.28)
  - o Remove 30-minute and 1-hour Private Programs and replace with Public and Private Education Programs\* (*Fees assessed based on materials cost, duration, impact and additional staff required.*)
  - o Add Public and Private Recreational Programs\* (*Fees assessed based on materials cost, duration, impact and additional staff required.*)
    - \*At the discretion of staff, private programming fees may be comped when appropriate if the group is willing to provide in kind service in the form of volunteer hours.
  - o Add to Specialty Camp – (*Fees include summer, winter, fall, spring and day camps*).
  - o Remove Covered Wagon Tours at Robinson Preserve and Duette Preserve and add Wagon Tours are free for the Public or Private with fee and Interpretive Guide.
  - o Add Birthday Parties with 30-minute or 60-minute package and with per group or per person fees.
  - o Add Additional Hands-on Activities or Guided Tours with per person fee.
  - o Delete Scouts Day Program fee per child and add 2-hour badge or patch class fee per group. *Additional fees for patches and/or additional participants may be applied.*
- j. Increase Jiggs Landing Rustic Cabin Rental fees per night and per week, and clarify – If Security Deposit(s) for cabin and keys are required, then the deposit(s) will be returned once verification of no damage is confirmed. (p.30)

2. Fee changes shall take effect as of January 1, 2018.

**BE IT FURTHER RESOLVED** that the provisions of this resolution are severable such that the invalidity of any one provision shall not operate to invalidate any other provision.
