

RESOLUTION R-19-040

A RESOLUTION OF THE MANATEE COUNTY BOARD OF COMMISSIONERS AUTHORIZING THE SIGNING AND SUBMISSION OF ANNUAL TRANSIT GRANT APPLICATIONS AND SUPPORTING DOCUMENTS AND ASSURANCES TO THE DEPARTMENT OF TRANSPORTATION, FEDERAL TRANSIT ADMINISTRATION, THE ACCEPTANCE OF GRANT AWARDS FROM THE DEPARTMENT OF TRANSPORTATION, FEDERAL TRANSIT ADMINISTRATION, AND THE PURCHASE OF VEHICLES AND/OR EQUIPMENT AND/OR EXPENDITURE OF GRANT FUNDS PURSUANT TO GRANT AWARDS

WHEREAS, the Manatee County Board of County Commissioners (BOCC) has the authority to file and accept Grant Agreements with the U.S. Department of Transportation, Federal Transit Administration (FTA); to undertake the approved Program of Projects and make purchases and/or expend funds pursuant to grant awards made by the Department of Transportation as authorized by Chapter 53 of Title 49 of the U.S. Code and/or by the Fixing America's Surface Transportation (FAST) Act, as amended; and

WHEREAS, the Public Works Department, Transit Division developed a Comprehensive Program of Projects for Federal Fiscal Year 2019, based upon the federal apportionment of formula funding for urbanized area transit programs.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MANATEE COUNTY, FLORIDA:

1. This Resolution applies to Federal Program(s) under U.S.C. Section(s) 5307 and 5339, as appropriated by Congress and signed into law for Federal Fiscal Year (FFY) 2019.
2. The submission of FFY 2019 FTA Section 5307 and 5339 grant application(s), supporting documents, and certifications and assurances to the Department of Transportation, Federal Transit Administration is hereby approved.
3. The Public Works Director or designee is hereby authorized to electronically sign and/or submit these applications and accept grant awards, and/or expend grant funds for approved purposes as identified in the FFY 2019 Program of Projects, pursuant to grant award, unless specifically rescinded.
4. The BOARD authorizes the Transit Division Manager to sign any and all assurances, amended applications, reimbursement invoices, warranties, certifications, extensions, and other documents which may be required in connection with these grant applications or subsequent grant agreements.
