**A RESOLUTION OF MANATEE COUNTY, FLORIDA, AUTHORIZING THE CHAIRMAN OF THE BOARD TO ENTER INTO AN AGREEMENT BETWEEN THE FEDERAL EMERGENCY MANAGEMENT AGENCY AND THE STATE OF FLORIDA, DIVISION OF EMERGENCY MANAGEMENT TO RECEIVE PUBLIC ASSISTANCE FOR ELIGIBLE DISASTER RELIEF ACTIVITIES RESULTING FROM HURRICANE IRMA.**

**WHEREAS**, pursuant to the provisions of section 401, Public Law 93-288, as amended by P.L. 113-2, 127 Stat. 4 (2013) and codified in 44 CFR, Part 206, Subpart H, summarized in Attachment E to the funding agreement, for FEMA Public Assistance Program, the President of the United States declared Manatee County eligible for emergency public assistance due to Hurricane Irma beginning September 10, 2017; and

**WHEREAS**, the Federal Emergency Management Agency (FEMA), as a result of the Presidential Declaration FEMA 4337-DR-FL, has made available federal funds for eligible disaster relief activities; and

**WHEREAS**, the FEMA-State Agreement governing the use of those funds requires the State to share in the total costs eligible for federal assistance; and

**WHEREAS**, Chapter 97-152, Laws of Florida, in specific appropriation 1114A, provides that Federal disaster assistance matching requirements shall be equally shared between the State and its subgrantees; and

**NOW, THEREFORE, BE IT RESOLVED** by the Board of County Commissioners of Manatee County, Florida, that:

1. **Modification #Z0770-6** - Modification #Z0770-6 to Subgrant Agreement Between the Division of Emergency Management and Manatee County Government is being presented to the Board with this agenda and is modified as follows:
  - a. This Modification shall be the final amendment to the Original Agreement executed by the Sub-Recipient and the Division.
  - b. All subsequent project worksheets and project worksheet versions shall be incorporated into the Original Agreement upon obligation.
  - c. The Scope of Work, Attachment A to the Original Agreement, will continue to be updated to reflect Federal funding obligated and will continue to be incorporated herein by reference.
  - d. All previous provisions of the Original Agreement being modified and any attachments thereto in conflict with this Modification shall be and are hereby amended to conform with this Modification, effective as of the date of the last execution of this Modification by both parties.
  - e. Section (C)(6), Modifications, of the Original Agreement, shall be amended to only read as, "Either party may request modification of the provisions of this Agreement. Changes which are agreed upon shall be valid only when in writing, signed by each of the parties, and attached to the original of this Agreement."
  - f. All provisions not in conflict with this Modification remain in full force and effect and are to be performed at the level specified in the Agreement.

2. The Chairman, or in his absence the Vice Chairman, is authorized to execute all appropriate documents with regards to the acceptance of this contract.
3. The Director of Financial Management is authorized to sign the agreement for Manatee County.
