

RESOLUTION NO. R-19-142

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONER OF MANATEE COUNTY, FLORIDA, AMENDING RESOLUTION R-19-068 OF THE PARKS AND NATURAL RESOURCES FEE SCHEDULE; PROVIDING FOR SEVERABILITY AND PROVIDING EFFECTIVE DATES.

WHEREAS, §125.01(1)(f), Florida Statutes, authorizes the Board of County Commissioners of Manatee County, Florida, as the legislative and governing body of Manatee County, to provide parks, preserves, playgrounds, recreation areas, and other recreation and cultural facilities and programs; and

WHEREAS, parks and natural resources services are funded in part by user fees generated to cover all or a portion of the costs of such services so as to minimize the burden on the County's general revenue;

WHEREAS, Manatee County's parks and preserves are open to the public and used for the operation of planned special events organized and supervised by the Parks & Natural Resources Department; and

WHEREAS, Manatee County Code §2-24-12 provides that the Board of County Commissioners may, upon recommendation of the Parks and Natural Resources Department Director, adopt, modify or rescind fees or fee ranges for access to various facilities or services offered by the County; and

WHEREAS, the County Commission has previously adopted various fees which have been made a part of the Parks and Natural Resources Master Fee Schedule, and

WHEREAS, the changes now recommended for adoption are based upon removals, additions, and clarification of rentals, services and program fee, and adding and increasing various fees throughout the Master Fee Schedule.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MANATEE COUNTY, FLORIDA, THAT:

1. The fees and charges in Resolution R-19-068 are hereby amended, providing for the following changes to the Master Fee Schedule:
 - a. Remove Fitness Center Membership (Grandfather Clause). (p.1)
 - b. Add definition of Off-Peak and Peak Seasons. (p.2)
 - c. Remove Racquetball & Hard-Court Tennis Membership (Grandfather Clause). (p.2)
 - d. Remove Seasonal Membership. (p.2.)
 - e. Add Outdoor Hockey Rink fee to Athletic Facility Rentals for Residential/Social and Commercial categories. (p.16)
 - f. Remove Grandfathered 3- and 6-month fees for Racquetball/Hard Court Tennis Membership. (p.17)
 - g. Increase Total Hours of Hard-Court Time included with G.T. Bray Daily Guest Pass. (p.18)
 - h. Remove Child Watch (non-members) fee. (p.18)
 - i. Clarify non-member Recreation Classes Non-Peak Season fee and Add a Peak Season fee. (p.18)
 - j. Remove expired granting of previous fee for a Personal Training Session. (p.18)
 - k. Add a 30-minute Team Training Session (staff led) with fees and number of trainees for each and increase 1-hour session fees with adjusted number of trainees. (p.18)
 - l. Add a 1-hour private Group Fitness Session (instructor led) and each Additional Participant fees. (p.19)
 - m. Add a Group Fitness Session Equipment Set-up fee. (p.19)

- n. Change all "instructor" references to "PT" on Personal Training Sessions and Trainer Facility Use fees to better define the type of instructor. (p.19)
- o. Remove "via Purchasing Department" throughout Fee Schedule. (p.20, 24, and 28)
- p. Add Pickleball Ball Machine rental hourly fee. (p.22)
- q. Add Mobile Food Truck Vendor Annual Application Processing fee and monthly Vendor Permit fee. (p.23)
- r. Increase staff operated Pickleball Tournament fee range. (p.27)
- s. Add fee ranges to Pickleball Group Clinic for all members and non-members. (p.27)
- t. Clarify that Private Lessons (Pickleball/Tennis) fees (\$30 and \$50) includes 1 participant. (p.27)
- u. Add staff led Private Lessons (Pickleball/Tennis) fees for 3-5, 6-9, and 10+ participants. (p.28)
- v. Add Social Pickleball League (staff led) fee ranges for members and non-members. (p.28)
- w. Add Adventure Camp weekly and prorated daily fees to Youth Camps programs. (p.29)
- x. Adjust Mosaic NEST Building Rental closing hours to accommodate cleanup activities. (p.33)
- y. Add two preserve Pavilion Rentals and decrease the capacities for all Preserve Pavilion Rentals. (p.33)
- z. Clarify that Wedding/Vow Renewal/Hand Fasting/Commitment Ceremony locations have very limited parking and decrease the capacity at several preserve sites for such events. (p.33)
- aa. Add an Emerson Point and Classroom Extended Use Maintenance fees. (p.33)
- bb. Add an Emerson Point Septic fee. (p.33)
- cc. Add an annual Non-motorized Vessel Medallion fee for Kayak/Paddleboard Vendor Permits. (p.34)

2. Fee changes shall take effect as of November 19, 2019.

BE IT FURTHER RESOLVED that the provisions of this resolution are severable such that the invalidity of any one provision shall not operate to invalidate any other provision.
