

RESOLUTION R-21-036

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF MANATEE COUNTY, FLORIDA, REGARDING THE COUNTY BUDGET; ESTABLISHING A BUDGET SUBMISSION DATE FOR CERTAIN CONSTITUTIONAL OFFICERS; ESTABLISHING BUDGET CONTENT REQUIREMENTS FOR CERTAIN CONSTITUTIONAL OFFICERS AND STATE OFFICIALS; PROVIDING FOR SEVERABILITY AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, Section 129.03(2), Florida Statutes provides that the Board of County Commissioners may, by Resolution, require that the budget requests of the Sheriff, the Clerk of the Circuit Court, and the Supervisor of Elections, be submitted by May 1st of each year.

WHEREAS, the Board of County Commissioners is authorized by Florida Statute 129.03(3)a to examine the tentative budget brought before the Commission.

WHEREAS, it is in the best fiscal interest of the County to establish the budget submission date and the budget content requirements set forth herein.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MANATEE COUNTY, FLORIDA, AS FOLLOWS:

SECTION 1 BUDGET SUBMISSION DATE. The Sheriff, the Clerk of the Circuit Court, and the Supervisor of Elections, shall each submit to the Board of County Commissioners a budget request for their respective offices for Fiscal Year 2021-2022 by May 1, 2021.

SECTION 2 BUDGET CONTENTS. The Sheriff, the Clerk of the Circuit Court, the Supervisor of Elections, the Property Appraiser, Court Administration, the State Attorney, the Public Defender, and the Guardian Ad Litem shall provide a complete budget submission highlighting all revenues and expenses their respective offices shall receive within the year of budget submission.

SECTION 3 SEVERABILITY. If any section, sentence, clause or other provision of this Resolution shall be held to be invalid or unconstitutional by a court of competent jurisdiction, such invalidity or unconstitutionality shall not be construed as to render invalid or unconstitutional the remaining sections, sentences, clauses or provisions of this Resolution.

SECTION 4. EFFECTIVE DATE. This Resolution shall take effect immediately upon its

adoption.
