

RESOLUTION R-21-047

A RESOLUTION OF THE MANATEE COUNTY BOARD OF COMMISSIONERS AUTHORIZING THE SIGNING AND SUBMISSION OF ANNUAL TRANSIT GRANT APPLICATIONS AND SUPPORTING DOCUMENTS AND ASSURANCES TO THE DEPARTMENT OF TRANSPORTATION, FEDERAL TRANSIT ADMINISTRATION, THE ACCEPTANCE OF GRANT AWARDS FROM THE DEPARTMENT OF TRANSPORTATION, FEDERAL TRANSIT ADMINISTRATION, AND THE EXPENDITURE OF GRANT FUNDS PURSUANT TO GRANT AWARDS

WHEREAS, the Manatee County Board of County Commissioners (BOCC) has the authority to file and accept Grant Agreements with the U.S. Department of Transportation, Federal Transit Administration (FTA); to undertake the approved Program of Projects and make purchases and/or expend funds pursuant to grant awards made by the Department of Transportation as authorized by Chapter 53 of Title 49 of the U.S. Code and/or by the Coronavirus Response and Relief Supplemental Appropriations Act of 2021 (CRRSAA), as amended; and

WHEREAS, the Public Works Department, Transit Division will utilize Federal Fiscal Year 2021 apportioned CRRSAA of funding for urbanized area transit operating programs.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MANATEE COUNTY, FLORIDA:

1. This resolution applies to Federal the CRRSAA Program under U.S.C. Section(s) 5307 as appropriated by Congress for Federal Fiscal Year 2021.
2. The BOCC has the authority to file and submit FTA CRRSAA/Section 5307 grant application(s), supporting documents, and certifications and assurances to the Department of Transportation, Federal Transit Administration (FTA) is hereby approved.
3. The Public Works Director or designee, is hereby authorized to electronically sign and/or submit these applications and accept grant awards, and/or expend grant funds for approved purposes as identified in the Federal Fiscal Year 2021/CRRSAA Grant Program, pursuant to grant award, unless specifically rescinded.
4. The BOARD authorizes the Transit Division Manager to sign any and all assurances, amended applications, reimbursement invoices, warranties, certifications, extensions, and other documents which may be required in connection with these grant applications or subsequent grant agreements.
