

RESOLUTION R-21-075

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF MANATEE COUNTY FLORIDA, AUTHORIZING THE SUBMISSION AND ACCEPTANCE OF AN EDWARD BYRNE MEMORIAL JUSTICE ASSISTANCE GRANT (JAG) PASSED THROUGH THE FLORIDA DEPARTMENT OF LAW ENFORCEMENT (FDLE); AUTHORIZING THE CHAIRPERSON, THE COUNTY ADMINISTRATOR OR THE DEPUTY COUNTY ADMINISTRATOR TO EXECUTE ALL NECESSARY DOCUMENTS RELATED TO THE GRANT SUBMISSION AND ACCEPTANCE; AND AUTHORIZING THE NEIGHBORHOOD SERVICES DEPARTMENT DIRECTOR OR HER DESIGNEE TO EXECUTE ALL APPROPRIATE DOCUMENTS AND AGREEMENTS WHICH MAY BE REQUIRED IN CONNECTION WITH GRANT FUNCTIONS.

WHEREAS, Manatee County has determined that submission and acceptance of an Edward Byrne Memorial Justice Assistance Grant passed through the Florida Department of Law Enforcement is in the best interests of the welfare of the citizens of Manatee County.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MANATEE COUNTY, FLORIDA AS FOLLOWS:

1. The submission and acceptance of Edward Byrne Memorial Justice Assistance Grant passed through the Florida Department of Law Enforcement in the amount of \$103,811 is hereby authorized.
2. The Manatee County Public Safety Coordinating Council is designated as the Edward Byrne Memorial Justice Assistance Grant Advisory Board.
3. The Chairperson, or in her absence, the Vice Chairperson of the Board of County Commissioners, or the County Administrator or the Deputy County Administrator are authorized to execute all necessary documents with regards to submission and acceptance of this grant.
4. The Neighborhood Services Department Director or her designee, is authorized to execute all appropriate documents and agreements which may be required in connection with Justice Assistance Grant functions.
