

RESOLUTION NO. R-21-086

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF MANATEE COUNTY, FLORIDA REGARDING THE PARKS AND NATURAL RESOURCES DEPARTMENT; APPROVING THE UNIVERSAL FORM AGREEMENT FOR RECREATIONAL CONTRACTORS, OFFICIALS AND INSTRUCTORS OF THE PARKS AND NATURAL RESOURCES DEPARTMENT; PROVIDING FOR THE DELEGATION OF AUTHORITY TO EXECUTE THE UNIVERSAL FORM AGREEMENT FOR RECREATIONAL CONTRACTORS, OFFICIALS AND INSTRUCTORS; RESCINDING AND REPEALING RESOLUTION NO. R-18-175; PROVIDING FOR REPORTING; PROVIDING FOR SEVERABILITY; PROVIDING FOR APPLICABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, pursuant to Section 125.01, Florida Statutes, Manatee County, a political subdivision of the State of Florida, through its Parks and Natural Resources Department provides recreational programming for the citizens of Manatee County, Florida; and

WHEREAS, pursuant to Resolution No. R-18-175, the Board of County Commissioners approved the form of, and delegated the authority of the Director of Parks and Natural Resources, to enter into a universal form agreement ("Agreement") for recreational contractors, officials and instructors for recreational programming in Manatee County ; and

WHEREAS, Manatee County's Parks and Natural Resources Department (the "Department") desires to revise and update the Agreement and the accompanying payment schedule for all recreational contractors, officials and instructors for recreational programming in Manatee County; and

WHEREAS, the Board of County Commissioners (the "Board") has determined that it is necessary and in the best interest of the County to approve the form of, and delegate authority to execute, the Agreement and payment schedule for recreational contractors, instructors and officials, as provided in this Resolution.

NOW, THEREFORE, BE IT RESOLVED BY THE MANATEE COUNTY BOARD OF COUNTY COMMISSIONERS AS FOLLOWS:

SECTION 1. APPROVAL OF THE UNIVERSAL FORM AGREEMENT AND PAYMENT SCHEDULE FOR RECREATIONAL CONTRACTORS, OFFICIALS AND INSTRUCTORS OF THE PARKS AND NATURAL RESOURCES DEPARTMENT.

The Board hereby approves the form of the following documents for the Department's recreational programming:

Exhibit (A) - Universal Agreement for Recreational Contractors, Instructors and Officials of the Manatee County Parks and Natural Resources Department-attached

Exhibit (B) - Payment Schedule for Independent Contractors, Recreational Officials and Instructors-attached.

SECTION 2. DELEGATION OF AUTHORITY TO EXECUTE. The Director of the Parks and Natural Resources Department (the "Director"), or his designee, is hereby authorized and directed to execute the Agreement substantially in the form set forth in the above referenced exhibit to this Resolution, with such supplemental documents as are incorporated therein and consistent therewith.

SECTION 3. RESCIND AND REPEAL OF RESOLUTION NO. R-18-175. Resolution No. R-18-175 is hereby rescinded and repealed in its entirety, and upon adoption of this Resolution, shall be of no further force and effect.

SECTION 4. REPORTING. The Director shall annually provide a list to the Board of all agreements approved and executed pursuant to Section 1, above.

SECTION 5. SEVERABILITY. If any section, sentence, clause or other provision of this Resolution shall be held to be invalid or unconstitutional by a court of competent jurisdiction, such invalidity or unconstitutionality shall not be construed as to render invalid or unconstitutional the remaining sections, sentences, clauses or provisions of this Resolution.

SECTION 6. APPLICABILITY. The form of the agreement and general conditions approved herein shall apply and be utilized in all transactions entered on or after the effective date hereof.

SECTION 7. EFFECTIVE DATE. This Resolution shall take effect immediately upon its adoption.
