

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF MANATEE COUNTY, FLORIDA, ACCEPTING A GRANT AWARD FROM THE STATE OF FLORIDA, DIVISION OF EMERGENCY MANAGEMENT, FOR EMERGENCY MANAGEMENT PERFORMANCE GRANT FUND AGREEMENT.

**WHEREAS**, the State of Florida, Division of Emergency Management, provides funding to eligible local governments to conduct certain emergency management activities; and

**WHEREAS**, the State of Florida, Division of Emergency Management has awarded Manatee County Government funding to participate in emergency management activities; and

**WHEREAS**, the Board of County Commissioners of Manatee County, Florida has determined that participation in the Emergency Management Assistance Program will promote the health, safety and welfare of the citizens of Manatee County; and

**WHEREAS**, the Emergency Management Division shall perform activities to complete the required State Scope of Work.

**NOW THEREFORE BE IT RESOLVED**, by the Board of County Commissioners of Manatee County, Florida, that:

1. A grant award from the State of Florida, Division of Emergency Management, for the period of July 1, 2021 through June 30, 2022 for the Emergency Management Performance Grant (EMPG) in the amount of \$122,906 is hereby accepted.
2. The Chairman, or in their absence the Vice Chairman, is authorized to execute all appropriate documents with regards to the acceptance of the grant.
3. The Board authorizes the Public Safety Director to sign any other documents which may be required in connection with the Emergency Management Performance Grant FY 2021-2022 or subsequent supplemental agreements.

RESOLUTION B-21-108  
AMENDING THE ANNUAL BUDGET  
FOR MANATEE COUNTY, FLORIDA  
FOR FISCAL YEAR 2021

**WHEREAS,** Florida Statutes 129.06, authorizes the Board of County Commissioners to amend its budget for the current fiscal year as follows:

- a) Appropriations for expenditures in any fund may be decreased and other appropriations in the same fund correspondingly increased, provided the total appropriations of the fund are not changed.
- b) Appropriations from reserves may be made to increase the appropriation for any particular expense in the same fund, or to create an appropriation in the fund for any lawful purpose.
- c) Unanticipated revenues, including increased receipts for enterprise or proprietary funds, may be appropriated for their intended purpose, and may be transferred between funds to properly account for the unanticipated revenue.

**NOW, THEREFORE,** BE IT RESOLVED by the Board of County Commissioners of Manatee County, Florida that the 2020-2021 budget is hereby amended in accordance with FS 129.06 as described in the description and specified in the budget adjustment batch file listed below:

Department: PUBLIC SAFETY

Fund: GRANTS > 7/03

Fund: GENERAL FUND

Description: Appropriates \$122,906 of grant revenue in the Grants fund from the Department of Homeland Security (DHS) for the Emergency Management Performance Grant (EMPG) Agreement Number: G0273. Also, transfers \$17,100 from the Emergency Management operating account key within the General fund to the Grants fund. This grant is effective July 1, 2021 through June 30, 2022. Grant money will be used to fund half of the cost for two full time Emergency Management Officers. The remaining funds will be used to complete the Florida Division of Emergency Management required scope of work items. This is a dollar for dollar match grant using Emergency Management Preparedness Assistance Grant (EMPA) to the Board and the Emergency Management General Fund budget. This budget amendment is being presented to the Board of County Commissioners along with the award.
