

**RESOLUTION R-21-191**

**A RESOLUTION OF THE MANATEE COUNTY BOARD OF COMMISSIONERS AUTHORIZING THE SIGNING AND SUBMISSION OF ANNUAL GRANT APPLICATIONS AND SUPPORTING DOCUMENTS AND ASSURANCES TO THE FLORIDA DEPARTMENT OF TRANSPORTATION, THE ACCEPTANCE OF A GRANT AWARD FROM THE FLORIDA DEPARTMENT OF TRANSPORTATION AND THE EXPENDITURE OF CAPITAL/OPERATING ASSISTANCE GRANT FUNDS PURSUANT TO GRANT AWARD**

**WHEREAS**, the Manatee County Board of County Commissioners has the authority to apply for and accept grants and make purchases and/or expend funds pursuant to grant awards made by the Florida Department of Transportation as authorized by Chapter 341, Florida Statutes and/or by the Federal Transit Administration (FTA) Act of 1964, as amended; and

**WHEREAS**, the Florida Department of Transportation (FDOT) has the authority to administer FTA Section 5310 Program funding as the Designated Recipient for the Sarasota/Bradenton Urbanized Area (UZA) as established by FAST Act.

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MANATEE COUNTY, FLORIDA:**

1. This authorizing Resolution applies to Federal Program(s) under U.S.C. Section(s) 5310 Formula Grants for the Enhanced Mobility of Seniors and Individuals with Disabilities.
2. The Chairperson or in their absence, the Vice Chairperson, is hereby authorized to sign the FTA Section 5310 grant applications.
3. The Public Works Director, or designee, is authorized to accept the grant award, and execute grant agreements for both FTA Section 5310 capital and operating assistance funding; and upon grant agreement execution, authorized to proceed with expenditure of capital/operating grant funds pursuant to a grant award, unless specifically rescinded.
4. The BOARD authorizes the Transit Division Manager to sign any and all amended section 5310 grant applications, assurances, reimbursement invoices, warranties, certifications, extensions, and other documents which may be required in connection with the application or subsequent agreements.
