
**ORDER OF REFERRAL TO THE BOARD OF COUNTY COMMISSIONERS**

THIS CAUSE came on for hearing before the Code Enforcement Special Magistrate of Manatee County, Florida, on September 27, 2023, after due notice to Respondent, and the Special Magistrate having heard testimony under oath, received evidence and heard argument, thereupon issues this Order of Referral Order as follows:

1. The Compliance Order(s) issued on July 26, 2017 found that the original owner(s) Fernando Mendoza Hernandez was/were the owner(s) or person(s) in charge of the property located at 6321 279<sup>th</sup> St E., Myakka City, FL and identified in the Manatee County Property Appraiser's records as: PIN 324000109, and that the property was in violation of Section 310.3 of the Manatee County Land Development Code, in that Respondent has electric installed in a Quonset hut without the required building permit.
2. The Compliance Order imposed a fine of \$75.00 per day, for each and every day any violation(s) described herein continued past August 18, 2017.
3. As of the date of the hearing, fines imposed against Respondent(s) totaled \$25,753.50 which includes \$28.50 recording fees. A certified copy of the Order of Imposing Fine/Lien issued on September 18, 2017 was recorded in the Public Records of Manatee County Book 2692, Page 5253 and thereafter constituted a lien against the above-described property and upon any other real or personal property owned by Respondent(s) pursuant to Section 162.09, Florida Statutes, and Section 2-7-27 of the Manatee County Code of Ordinances.
4. The corrective action ordered in the Compliance Order has been completed and the property is now in compliance with Manatee County Land Development Code.
5. Justification exists to refer this case to the Manatee County Board of County Commissioners with a recommendation to reduce the outstanding fines to \$1,000.00 plus \$28.50 in recording fees.
