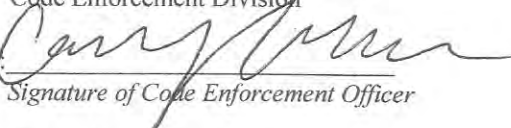

ORDER OF DISMISSAL

THIS CAUSE came on for hearing before the Code Enforcement Special Magistrate of Manatee County, Florida on August 26, 2026, after due notice to Respondent, and the Special Magistrate having heard testimony under oath, received evidence and heard argument, thereupon issues this Order as follows:

FINDINGS OF FACT

1. Respondent, J2R Enterprises LLC, whose mailing address is 6106 8th Ave Dr. NE, Bradenton, Florida, is the owner or person in charge of the property located at 5415 33rd St E., Bradenton, Florida, and identified in the Manatee County Property Appraiser's records as: PID 1771910054.

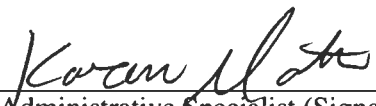
