STIPULATIONS:

- 1. All landscaped areas shall be irrigated with a 100% automatic irrigation system which adequately covers all landscaped areas. Landscaping shall be considered a part of the required improvements which shall be certified by the Planning, Permitting and Inspections Department prior to operation of the park.
- The emergency storm shelter shall receive a Certificate of Occupancy before construction begins on phase 3 (25th lot).

SPECIFIC APPROVALS:

- Specific approval for an alternative to the requirements of Section 603.9.4.3(3) of the Land Development Code to allow a reduction in the required width of lots for park trailers from 35 feet to 32 feet.
- Specific approval for an alternative to the requirements of Section 603.9.6.1(1) of the Land Development Code to allow a reduction in the pavement width from 18 feet to 16 feet for one way travel lanes.
