FINAL ORDER OF MANATEE COUNTY HEARING OFFICER DENNIS STOTTS ON BEHALF OF MANATEE COUNTY GRANTING Α SPECIAL PERMIT NO. SP-16-03 TO ALLOW AN ANIMAL SERVICES (WILD AND EXOTIC) FACILITY IN THE FORM OF A WILDLIFE SANCTUARY IN THE A/NCO AGRICULTURAL/NORTH CENTRAL OVERLAY DISTRICT) ZONING DISTRICT LOCATED AT 13910 AND 13920 SEMINOLE TRAIL, WIMAUMA (MANATEE COUNTY) 6.69± AND 6.91± ACRES RESPECTIVELY: PROVIDING FOR SEVERABILITY: AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Board of County Commissioners of Manatee County adopted the Manatee County Land Development Code, Manatee County Ordinance 90-01, as amended; and

WHEREAS, pursuant to the Land Development Code, Manatee County Ordinance 15-17, as amended, the Hearing Officer has the authority to grant Special Permits; and

WHEREAS, Elmira's Wildlife Sanctuary, Inc. requested a Special Permit to allow an animal services wild and exotic) facility in the form of a wildlife sanctuary in the A/NCO (General Agricultural/North Central Overlay) zoning district; and

WHEREAS, on June 14, 2016 the aforementioned Hearing Officer held a public hearing to receive the staff report, applicant, and public comment, and argument regarding the proposed Special Permit for an animal services (wild and exotic) facility in the form of a wildlife sanctuary.

NOW, THEREFORE, after consideration of the application for Special Permit 16-03 requested by Elmira's Wildlife Sanctuary, Inc. the Hearing Officer makes the following Findings of Fact and Conclusions of Law and issues the Final Order as follows:

<u>Section 1. Findings of Fact.</u> The aforementioned Hearing Officer, after considering comment, argument, evidence, documentation and staff report presented, as well as all other matters presented at the Public Hearing above referenced, hereby makes the following Findings of Fact:

- A. The site in in the AG-R (Agriculture Rural one dwelling unit per acre) Future Land Use Category.
- B. The request is to approve a Special Permit to allow an Animal Services (Wild and Exotic) facility in the form of a wildlife sanctuary at 13910 and 13920 Seminole Trail, Wimauma (Manatee County).

- C. The site is two properties 13910 Seminole Trail is 6.69± acres and 13920 Seminole Trail is 6.91± acres zoned A/NCO (General Agricultural/North Central Overlay District).
- D. The overall site lies within Zone X per FIRM Panel 120153 0065B.
- E. There are no wetlands on the property and there is no tree removal and replacement proposed.

<u>Section 2. Conclusions of Law.</u> Based upon the prior Findings of Fact and considering the testimony, evidence, documentation and the staff report presented, and a review of the applicable provisions of the Manatee County Comprehensive Plan and Manatee County Land Development Code, the above referenced Hearing Officer hereby makes the following Conclusions of Law:

- A. This Hearing Officer has jurisdiction over the parties and subject matter in this proceeding pursuant to the Land Development Code.
- B. The applicant has the burden of proving entitlement to the Special Permit it seeks. <u>Irvine v. Duval County Planning Commission</u>, 495 So.2d 167 (Fla. 1986); <u>Florida Department of Transportation v. J.W.C. Company, Inc.</u>, 396 So.2d 778 (Fla. 1st DCA 1981).
- C. The proposed use is consistent with the Comprehensive Plan Policies 2.2.1.8.2 which lists farms, ranches, agriculturally compatible residential uses, rural residential uses, public and semi-public uses in the range of potential uses in the AG-R (Residential 0.2 dwelling units per acre) Future Land Use Categories, and 2.1.2.7 which requires review for all proposed development for compatibility and appropriate timing.
- D. The applicant has met present requirements of the Manatee County Comprehensive Plan and present requirements for the issuance of a Special Permit pursuant to the Manatee County Land Development Code, Sections 316 (Special Permit Criteria), 531.5 (Standards for Specific Uses Animal Services[Wild and Exotic Animals]).
- E. Adequate measures have been taken to provide ingress and egress to the site.
- F. Adequate measures have been taken to ensure that the proposed use is consistent with the community character of the surrounding development and community.
- G. There are no known archaeological, historical, or cultural resources onsite.
- H. Adequate provisions have been made for buffers, landscaping, parking

areas, and other improvements associated with the proposed use.

<u>Section 3. Order.</u> Based upon the foregoing, a Special Permit is hereby approved and issued to Elmira's Wildlife Sanctuary, Inc. and more particularly described in Exhibit "A" attached hereto and incorporated herein, for a Special Permit allow/deny an Animal Services (Wild and Exotic) facility in the form of a wildlife sanctuary at 13910 and 13920 Seminole Trail, Wimauma (Manatee County), subject to the following conditions:

- 1. This Special Permit shall not be effective until it has been recorded in the Public Records of Manatee County, Florida by the applicant and a copy of the recorded Order is received by the Planning Department.
- 2. The Special Permit will serve as a Final Site Plan (Plot Plan standards) upon approval of the Special Permit.
- 3. The site plan submitted with this application shall be part of this approval.
- 4. Parking bumper will be placed at the end of all parking stalls on site
- 5. Entrance at Seminole Trail must be paved from the edge of roadway to the existing right of way line.
- 6. The driveway isle width will require to be 24 feet wide to accommodate backing out on to the drive aisle.
- 7. All necessary state permits shall be obtained for the housing of wild or exotic animals and all the conditions of the state permits shall be met.
- 8. The applicant shall provide informational material stating to "drive cautiously when visiting Elmira's Wildlife Sanctuary."

<u>Section 4. Severability.</u> In the event that any portion or section of this Order is determined to be invalid, illegal or unconstitutional by a court of competent jurisdiction, such decisions shall in no manner affect the remaining portions or sections of the Special Permit which shall remain in full force and effect.

<u>Section 5. Effective Date</u>. The effective date of this Special Permit shall be upon execution of this Order and its recordation in the Official Records by the applicant with the Office of the Clerk of the Circuit Court and receipt of a copy of the recorded Order by the Building and Development Services Department.
