## MANATEE COUNTY ZONING ORDINANCE Z-03-04 – RANDY CONNER

AN ORDINANCE OF THE COUNTY OF MANATEE, FLORIDA, AMENDING THE OFFICIAL ZONING ATLAS OF MANATEE COUNTY ORDINANCE NO. 90-01 (THE MANATEE COUNTY LAND DEVELOPMENT CODE), RELATING TO ZONING WITHIN THE UNINCORPORATED AREA OF MANATEE COUNTY; PROVIDING FOR THE REZONING OF CERTAIN LAND FROM A (GENERAL AGRICULTURE, 1 DWELLING UNIT PER 5 ACRES) TO A-1 (SUBURBAN AGRICULTURE, 1 DWELLING UNIT PER ACRE); PROVIDING AN EFFECTIVE DATE.

BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF MANATEE COUNTY, FLORIDA:

Section 1. <u>FINDINGS OF FACT</u>. The Board of County Commissioners of said County, after considering the testimony, evidence, documentation, application for amendment of the Official Zoning Atlas, the recommendation and findings of the Planning Commission of said County, as well as all other matters presented to said Board at the public hearing hereinafter referenced, hereby makes the following findings of fact:

- A. The Board of County Commissioners has received and considered the report of the Manatee County Planning Commission concerning the application for Official Zoning Atlas Amendment as it relates to the real property described in Section 3 of this Ordinance from A (General Agriculture, 1 dwelling unit per 5 acres) to A-1 (Suburban Agriculture, 1 dwelling unit per acre).
- B. The Board of County Commissioners held a public hearing on November 18, 2003 regarding said proposed Official Zoning Atlas Amendment described herein in accordance with the requirements of Manatee County Ordinance No. 90-01, the Manatee County Land Development Code, and has further considered the information received at said public hearing.
- C. The proposed amendment to the Official Zoning Atlas regarding the property described in Section 3 herein is found to be consistent with the requirements of Manatee County Ordinance No. 89-01, the Manatee County Comprehensive Plan.
- Section 2. <u>AMENDMENT OF THE OFFICIAL ZONING ATLAS</u>. The Official Zoning Atlas of Manatee County, Ordinance No. 90-01, the Manatee County Land Development Code, is hereby amended by changing the zoning from A (General Agriculture, 1 dwelling unit per 5 acres) to A-1 (Suburban Agriculture, 1 dwelling unit per acre), and the Clerk of the Circuit Court, as Clerk to the Board of County Commissioners, as well as the Planning Department, are hereby instructed to cause such amendment to the said Official Zoning Atlas.

## Section 3. <u>LEGAL DESCRIPTION</u>.

COMMENCE AT THE SE CORNER OF SECTION 14, TOWNSHIP 36 SOUTH, RANGE 21 EAST, MANATEE COUNTY, FLORIDA; THENCE N 89° 32′ 45″ W, ALONG THE SOUTH LINE OF SAID SECTION, 861.95 FEET FOR A POINT OF BEGINNING; THENCE CONTINUE N 89° 32′45″ W, ALONG THE SOUTH LINE OF SAID SECTION, 871.39 FEET TO SINGLETARY ROAD; THENCE N 51° 33′ 49″ E, ALONG SAID ROAD, 796.53 FEET; THENCE S 26° 14′ 11″ 3, 559.73 FEET TO THE POINT OF BEGINNING. BEING AND LYING IN SECTION 14, TOWNSHIP 36 SOUTH, RANGE 21 EAST, MANATEE COUNTY, FLORIDA AND CONTAINING 5.00 ACRES, MORE OR LESS.

Section 4. <u>EFFECTIVE DATE</u>. This ordinance shall take effect immediately upon filing with the Office of the Secretary of State, Florida Department of State.
