AN ORDINANCE OF THE COUNTY OF MANATEE, FLORIDA, AMENDING THE OFFICIAL ZONING ATLAS OF MANATEE COUNTY ORDINANCE NO. 81-4, THE MANATEE COUNTY COMPREHENSIVE ZONING AND LAND DEVELOPMENT CODE RELATING TO ZONING WITHIN THE UNINCORPORATED AREA OF MANATEE COUNTY: PROVIDING FOR THE REZONING OF CERTAIN LAND FROM R-2 (ONE AND TWO, FAMILY DWELLING DISTRICT) TO R-3B (MULTI-FAMILY, RESIDENTIAL DISTRICT) PROVIDING AN EFFECTIVE DATE.

BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS MANATEE COUNTY, FLORIDA:

Section 1. FINDINGS OF FACT - The Board of County Commissioners of said County, after considering the testimony, evidence, documentation, application for amendment of the Official Zoning Atlas, the recommendation and findings of the Planning Commission of said County as well as all other matters presented to said Board at the Public Hearing hereinafter referenced, hereby makes the following findings of fact:

- A. The said Board of County Commissioners has received and considered the report of the Manatee County Planning Commission concerning application for Official Zoning Atlas be amended as relates to the real property described in Attachment "A" to this Ordinance from R-2 (One and Two Family Dwelling District) to R-3B (Multi-Family Residential District).
- B. The said Board of County Commissioners held a Public Hearing on August 27, 1981, on the proposed Official Zoning Atlas Amendment described herein in accordance with the requirements of Manatee County Ordinance No. 81-4, THE MANATEE COUNTY COMPREHENSIVE ZONING AND LAND DEVELOPMENT CODE, and has further considered the information received at said Public Hearing.
- C. The proposed amendment to the Official Zoning Atlas regarding the property described in Attachment "A" hereto is found to be consistent with the requirements of Manatee County Ordinance No. 80-4, THE MANATEE PLAN.
- Section 2. The Conceptual Plan titled Elmore Subdivision is hareby APPROVED.
- Section 3. AMENDMENT OF OFFICIAL ZONING ATLAS The Official Zoning Atlas of Manatee County Ordinance No. 81-4, THE MANATEE COUNTY COMPREHENSIVE ZONING AND LAND DEVELOPMENT CODE, is hereby amended by changing the zoning district classification of the property identified in Attachment "A" hereto from R-2 (One and Two Family Dwelling District) to R-3B (Multi-Family Residential District), in accordance with the approved Conceptual Flan, and the Clerk of the Circuit Court, as Clerk to the Board of County Commissioners, as well as the Planning and Development Department are hereby instructed to cause such amendment to be reflected upon said Official Zoning Atlas.
- Section 4. EFFECTIVE DATE This Ordinance shall take effect immediately upon the receipt of the official acknowledgment from the Office of the Secretary of State, State of Florida, that same has been filed with that office.
