BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF MANATEE COUNTY, FLORIDA:

Section 1. FINDINGS OF FACT The Board of County Commissioners of said County, after considering the testimony, evidence, documentation, application for amendment of the Official Zoning Atlas, the recommendation and findings of the Planning Commission of said County as well as all other matters presented to said Board at the Public Hearing hereinafter referenced, hereby makes the following findings of fact:

A. The Board of County Commissioners has received and considered the report of the Manatee County Planning Commission concerning the application for Official Zoning Atlas Amendment as it relates to the real property described in Section 3 of this Ordinance from C-1 (General Commercial) to C-2 (Heavy Commercial).

B. The said Board of County Commissioners held a Public Hearing on December 10th, 1987 regarding said proposed Official Zoning Atlas Amendment described herein in accordance with the requirements of Manatee County Ordinance No. 81-4, THE MANATEE COUNTY COMPREHENSIVE ZONING AND LAND DEVELOPMENT CODE and has further considered the information received at said Public Hearing.

C. The proposed amendment to the Official Zoning Atlas regarding the property described in Section 3 herein is found to be consistent with the requirements of Manatee County Ordinance No. 80-4, THE MANATEE PLAN.

Section 2. AMENDMENT OF OFFICIAL ZONING ATLAS The official Zoning Atlas of Manatee County Ordinance No. 81-4, THE MANATEE COUNTY COMPREHENSIVE ZONING AND LAND DEVELOPMENT CODE is hereby amended by changing the zoning district classification of the property identified in Section 3 herein from C-1 (General Commercial) to C-2 (Heavy Commercial), and the Clerk of the Circuit Court, as Clerk to the Board of County Commissioners, as well as the Planning and Development Department are hereby instructed to cause such amendment to the said Official Zoning Atlas.

Section 3. Legal Description:

DP 58743: Begin 200 feet West of the NE corner of Lot 1, BLOCK & LUDGIN SUB., as per plat thereof recorded in Plat Book 7, page 5, Public Records of Manatee County, Florida; thence South 212.9 ft., mol, to the South line of said Lot 1; thence West 100 ft. thence North 212.9 ft., mol, to the North line of said Lot 1; thence East 100 feet to the Point of Beginning.

and also

DP 58741: Beginning 100 feet West from the NE corner of Lot 1, thence West 100 feet, thence South 212 feet, thence East 100 feet, thence North 212 feet to the point of beginning of Lot 1 of BLOCK & LUDGIN SUB. as per plat thereof recorded in Plat Book 7, Page 5 of the Public Records of Manatee County, Florida.

DP 58739: The East 100 feet of Lot 1, BLOCK & LUDGIN SUB. as per Plat thereof recorded in Plat Book 7, Page 5, Public Records of Manatee County, Florida.
